Facts & circumstances of collection of your personal information	Your personal information is collected: <ul style="list-style-type: none"> • directly from you when you give your personal information to us • by third parties such as from service providers, entities and clubs sponsored by or affiliated with us, or from our contractors and agents • from publicly available sources • as otherwise permitted or required by law.
If collection of your personal information is required or authorised by law	If we are collecting your personal information for the conduct of a safety recall under the Competition & Consumer Act (Cth) 2010, collection of your personal information from Government entities may be required or authorised by law, or otherwise necessary in order to conduct the safety recall.
Why does Genesis Motors Australia collect your personal information?	The purposes for which we collect, hold, use and disclose your personal information will depend on the circumstances for which we collect it. For example, if we collect personal information in connection with your purchase of a motor vehicle from us, we may collect personal information to remind you in the future that your vehicle is due for a service. In general, we may use and disclose your personal information for the purposes for which we collect it and related purposes which you would reasonably expect, for purposes which you consent, and as otherwise authorised or required by law.
The consequences if Genesis Motors Australia did not collect your personal information	If we are unable to collect personal information we require, we may not be able to do business with you or the organisation with which you are connected, or advise you of information in relation to Genesis vehicles, parts, accessories or Genesis Motors Australia services or offers. For example, if we did not collect personal information about your new vehicle purchase, we would be unable to remind you directly of a service that is due, or notify you of a field service action for the vehicle.
Additional information for users of Genesis Connected Services and Genesis Connected Services app	If you use our Genesis Connected Services or the Genesis Connected Services app, then we may also collect additional information (some of which may be personal information about you), including: <ul style="list-style-type: none"> • the number of trips and distances that you have driven; • the location of your vehicle, including historical locations; • vehicle diagnostic information, such as tyre pressure, amount of fuel in the tank and engine information; • vehicle driving information, such as speed, braking, cornering and acceleration information; • airbag deployment or call information if you contact roadside assistance services; • mobile phone information such as number, model, operating system, search content, usage information relating to the Genesis Connected Services app and personal location data where you have activated location services on your mobile device; and • payment information (such as credit card, PayPal or bank details).

	<p>We may use and disclose this information to provide you with information and notifications in relation to your vehicle, including to inform you of a need for any maintenance or repairs and to allow you to book a service for your vehicle. We may disclose this information to our Genesis service centres, wireless service providers and other technology service providers in connection with the operation of the Genesis Connected Service. We may also disclose this information to insurance providers in order for them to provide tailored insurance policies to you. If your vehicle is provided by your employer as part of a corporate or government fleet policy, we may also disclose this information to your employer.</p>
Who will Genesis Motors Australia disclose your personal information to?	<p>Generally, Genesis Motors Australia may disclose your personal information to third parties in connection with the purposes described above. Usually, we may disclose your personal information to our Genesis service centres and vice versa.</p>
Access to and correction of your personal information	<p>Our Privacy Policy contains information about how you may access and seek correction of personal information about you that Genesis Motors Australia holds.</p>
Privacy complaints	<p>Our Privacy Policy contains information about how you may complain about a breach of the Australian Privacy Principles and how Genesis Motors Australia will deal with complaints.</p>
Likely overseas disclosure of your personal information	<p>Some of the third parties to whom we disclose personal information may be located outside Australia. For example, we may disclose personal information to our related companies within Hyundai Motor Group in South Korea. Other service providers may be located overseas. The countries in which these third parties are located will depend on the circumstances, but may include the United States and Canada.</p>
